This application is meant to be more than just an application; it is meant to be a processing and discernment tool. We hope that you will learn something about yourself, Servant Partners, and God in the process. We already see you as a valuable part of our family and look forward to getting to know you, regardless of what the end result will be.

Note that we are not looking for the "perfect Christian." We are looking for mature and sturdy believers who are seeking Jesus and His heart for the world, the lost, and the poor. Inexperience in one area or theological questions in another will not disqualify you, but they will be helpful for us to know how best to support you throughout the interview process and the internship. To that end, please answer as honestly as you can.

In addition to submitting this application, all applicants are required to submit reference forms from a pastor/missions chairperson/campus staff worker, an employer, and a friend/roommate. International applicants are also required to submit a physician's reference form. Please ask references who know you well enough to have helpful insight into your ministry experiences, personal life, character, and other parts of your day to day life. If the reference does not know you well it will show in what they are able to comment on and we will likely ask you for another reference.

Please send the Word documents to your reference forms. You will have the best results if you give your references a deadline and if they have at least two weeks to complete it before your deadline. If possible, all of your references (excluding the physician) should have known you for two years. Note: The Physician Reference Form is a downloadable PDF meant to be printed and taken to a physician, and **only applies to international internship applicants.**

Interview Process

Interview Weekend is the final step of the application process for all applying for internships 9 months or longer. Interview Weekend offers the opportunity to learn more about the internship on-site: meet staff members, current interns and other applicants, tour a neighborhood you may be living in, and discern more clearly if the internship is for you.

Interview Weekend is required. It will be at one of our sites. In 2021, Interview Weekend will be in San Jose, CA, dates to be determined. Upon reviewing your application, invitations for Interview Weekend will be sent out to applicants to continue the process.

If you are invited to Interview Weekend you will be expected to arrive no later than 4p.m. on Friday and departing no earlier than 3p.m. on Sunday. If necessary, scholarships will be available to help pay for travel expenses. Please contact <u>internships@servantpartners.org</u> in regards to Interview Weekend, travel arrangements, questions, and scholarships as soon as you know that you want to apply.

Internship Application Agreement

I have applied to participate in the Servant Partners Internship, and understand that if I am accepted, my participation in the program depends on the completion of all of the application materials and preparation requirements as determined by Servant Partners. I am aware that I need to discuss my participation in the program with my church leaders and family. I understand that Servant Partners needs to receive the entire cost of my program one month prior to my departure.

I will remember that my life, attitudes and actions reflect on others, Servant Partners and the Lord. If

unforeseen problems or conflicts should arise, I will seek to deal with them in a culturally appropriate and biblical way. I understand that while I am participating in this program, I am under the leadership of Servant Partners personnel and will accept and submit to their authority over me. I understand that Servant Partners maintains the right to remove me from the program at any point if my participation is hindering the on-going work of Servant Partners.

I realize that my role on the field is not that of a tourist, and I must act with cultural sensitivity while on the field. I will seek to glorify God by my lifestyle and attitude. This includes modesty and neatness in my dress, polite speech and behavior, as well as propriety in my relationships with those of the opposite sex. I will aim to be content in all circumstances, even if I will be living without modern conveniences. I will seek to be a learner, a team-player, and a respecter of the customs and national culture of the country in which I am serving. I will obey the local laws.

I understand the importance of one to one trusting relationships as a basis for effective sharing of the gospel. I will seek to be a witness with both my words and actions, and will avoid activities that could offend or harm others. I will submit to the authority of long-term workers in regards to ministry strategy and practices in the community.

As an Intern with Servant Partners I agree to fully respect the ministry of Servant Partners and the host community even after my term with the internship. I promise that I will not send money to any member of the local church and/or community resident without the approval of Servant Partners staff. I will inform Servant Partners staff of any requests I receive asking for any kind of financial assistance or gifts in kind. I agree that I will not return to the local community and church without first notifying Servant Partners staff of my intention and receiving written permission to do so.

I understand that I will need to inform my financial supporters that donations toward my program are to be sent to Servant Partners, P.O. Box 3144, Pomona, CA 91769 with "Internship Department/my name" in the memo portion of the check. I will also inform my supporters that any funds sent to Servant Partners, for which tax-deductible receipts have been issued, cannot be returned to them. I understand that all contributions are considered by the Internal Revenue Service to be donations to the Internships Department and if contributions exceed my personal program cost, excess funds will not be returned to donors or to me. If it is determined during the preparation time by myself or Servant Partners that I do not participate in this internship, I understand that, in order to satisfy IRS requirements, donations received on my behalf cannot be refunded to either my donors or to me. I am aware that if I am sent out by another agency within 12 months, Servant Partners will be able to forward funds to that organization on my behalf (excluding the amount of application fees and non-refundable costs).

Internship Participation Agreement

I acknowledge that I have applied to the Servant Partners Internship, and that if accepted by Servant Partners, Inc. (hereinafter "SP"),

I hereby represent and agree as follows:

- 1. I shall accept, abide by and follow all reasonable SP instructions and directions whether written or oral relating to my participation in this program.
- 2. I shall pay and be responsible for all expenses that I incur (other than those which SP has

- specifically agreed to pay in writing); and shall not seek reimbursement from SP or from any of its members, representatives, employees, contractors or agents ("related persons") for expenses which SP has not so agreed to pay.
- 3. I have no presently existing health or medical conditions or limitations, except those that I have disclosed in writing to SP as part of the application process for this travel. I understand that with respect to any such condition or limitation the decision to participate in this program is my own with the advice of my physician. SP and its related persons shall have no responsibility for any such condition. I accept full financial and other responsibility for any illness, injury, or death caused in whole or in part by any presently existing health or medical condition or limitation.
- 4. I accept full responsibility for and shall pay or reimburse SP for payment of any and all costs of health and medical care or treatment and for the cost of repatriation related to such, if required, incurred by me which are paid by SP, which are related to participating in this program. I shall not seek payment or reimbursement from SP for such costs or expenses, or any related costs or expenses which I pay myself. When traveling abroad, I understand that I will be covered under traveler's health insurance obtained with my funds on my behalf by SP, but before my departure, and upon my return to the United States, I am responsible for my own health insurance coverage and expenses. I understand that I am free to notify SP and purchase my own health care and "air ambulance" coverage, if it provides benefits substantially equal to or greater than those of the policy SP obtains on my behalf. [The policy SP provides may provide only limited air ambulance coverage for repatriation.] A copy of the travelers' health insurance policy will be provided to me, at my request, following my acceptance and receipt of the required internship fees as determined by the staff. I accept responsibility for understanding the extent of the coverage and any deductibles and co-pays. I agree that I (and not SP) must pay deductibles, co-pays, and expenses not covered by the policy.
- 5. I authorize SP and its related persons to obtain and authorize on my behalf any and all health and medical care and treatment for me in the event of my illness or injury and to obtain from physicians and hospitals and their staff all information relating to my medical condition. Neither SP nor any of its related persons shall have any liability for authorizing or failing to authorize any such care or treatment. Any physician or other health care provider or facility may render all care and treatment and perform all procedures, including anesthesia, deemed advisable in attempting to treat or relieve any health or medical condition. I acknowledge that medical care and treatment outside of the United States may be limited and may be below the standard that is usual and customary within the United States.
- 6. Neither I, my estate, members of my family nor anyone acting on behalf of myself or estate or family shall have or assert any claim or demand against SP or any of its related persons in the event of my death, injury, illness, or property damage or loss resulting from my participation in this program, unless caused by their gross negligence or willful misconduct. SP and its related persons shall not be responsible for the negligence or misconduct of any person or entity providing health care to me.
- 7. I shall indemnify and hold SP and each of its related persons harmless in the event of any claim or liability by reason of any actual or alleged act or omission alleged to have been caused or performed by me, or by any reason of any breach or alleged breach on my part of this agreement. I agree to pay any and all attorneys fees, costs of suit, and incidental expenses of SP and its related persons therein incurred by reason of such claim, liability, or breach.
- 8. I acknowledge and agree that my participation in this program may be terminated at any time by SP, with or without cause.
- 9. I consent to being filmed, quoted, recorded and photographed by SP during this internship (as long as I am aware of it), and agree that SP may use and publish the same without payment.

- 10. I acknowledge that travel and participation in this program may involve substantial perils and risks of property damage, illness, bodily injury or death. In participating in this program, I hereby voluntarily accept and assume all said risks.
- 11. This agreement constitutes the sole and complete agreement between SP and me with respect to the subject matter, and no verbal or other statements or representations regarding this agreement have been made to me or are being relied upon by me. No modification of this agreement shall be binding unless in writing and signed by SP. This agreement shall be binding upon my executors, administrators, heirs, successors and assigns. If any portion of this agreement is determined to be unenforceable, this agreement shall nevertheless be interpreted to the extent possible to enforce or achieve the intent and purpose of said portion; and the remaining provisions of this agreement shall to the extent possible be unaffected and separately enforced. This agreement is made in Pasadena, California, and is effective upon receipt by SP.
- 12. Any dispute or controversy arising under or in connection with or related to this Agreement shall be settled exclusively by arbitration in California, in accordance with the Rules of the American Arbitration Association then in effect, before a single arbitrator. The selected arbitrator must render his or her decision in writing. Each party shall bear the costs and expenses of the arbitration and of enforcement of any award in any court. If advances are required, each party will advance one-half of the estimated fees and expenses of the arbitrators. Judgment may be entered on the arbitrators' award in any court having jurisdiction. The arbitrator shall have the power to grant equitable relief where available under California law, and shall not be entitled to make an award of punitive damages. The parties consent to jurisdiction and venue to enforce the award in any federal district court in the State of California, or any California court of general jurisdiction in Pasadena, California. In the event of any arbitration or litigation being filed or instituted between the parties concerning this Agreement, the prevailing party will be entitled to receive from the other party or parties its attorneys' fees, witness fees, costs and expenses, court costs and other reasonable expenses, whether or not such controversy, claim or action is prosecuted to judgment or other of relief. The "prevailing party" is that party which is awarded judgment or other legal or equitable relief as a result of trial or arbitration, or who receives a payment of money from the other party in settlement of claims asserted by such party. If both parties receive a judgment, settlement payment or other award or relief, the court or the arbitrator shall determine which party is the prevailing party, taking into consideration the merits of the claims asserted by each party, the relative values of the judgments, settlements or other forms of relief received by each party, and the relative equities between the parties.
